

**AN ORDINANCE TO AMEND THE CODE OF ATHENS-CLARKE COUNTY, GEORGIA WITH RESPECT TO VOTING PRECINCTS AND POLLING PLACES - POLLING PLACES FOR DISTRICTS 1A AND 1B, DISTRICT 2A, AND DISTRICT 3A; AND FOR OTHER PURPOSES.**

The Commission of Athens-Clarke County hereby ordains as follows:

SECTION 1. Sec. 1-2-1, entitled "Voting Precincts and Polling Places," Paragraphs (1)A, (1)B, (2)A, and (3)A, are hereby amended as follows:

"(1)A - Winterville Train Depot, 101 Marigold Lane, Winterville"

"(1)B - East Athens Baptist Church, 4325 Lexington Road"

"(2)A - Judia J. Harris Elementary School, 2300 Danielsville Road"

"(3)A - Clarke Central High School, 350 South Milledge Avenue"

So that after amendment said Section shall read as follows:

"Sec. 1-2-1. Voting precincts and polling places.

Each district of Athens-Clarke County shall constitute a voting precinct for any election, whether general, special, primary or other, and the polling place for each precinct shall be as follows:

(1) District 1:

A - Winterville Train Depot, 101 Marigold Lane, Winterville

B - East Athens Baptist Church, 4325 Lexington Road

C - Barnett Shoals School on Barnett Shoals Road

D - Whit Davis School, 1450 Whit Davis Road

(2) District 2:

A - Judia J. Harris Elementary School, 2300 Danielsville Road

B - Howard B. Stroud Elementary School, 715 Fourth Street

(3) District 3:

A - Clarke Central High School, 350 South Milledge Avenue

B - Thomas N. Lay Park, 297 Hoyt Street

(4) District 4:

A - Athens Transit Multi-Modal Center, 775 East Broad Street

B - Memorial Park on Gran Ellen Drive.

(5) District 5:

A - Oglethorpe School on Oglethorpe Avenue

B - Whitehead Road School, 500 Whitehead Road

C - Chase Street School on North Chase Street

D - ACC Fleet Management Building, 225 Newton Bridge Road

(6) District 6:

A - Cleveland Road School on Cleveland Road

B - Board of Education, 240 Mitchell Bridge Road

C - Timothy Road School, 1900 Timothy Road

D - Fire Station Number 4, Oglethorpe Avenue

(7) District 7:

A - Timothy Baptist Church, 380 Timothy Road

B - Alps Road Elementary School, 200 Alps Road

C - Fire Station Number 3, 1198 South Milledge Avenue

(8) District 8:

A - Gaines Elementary School, 900 Gaines School Road

B - Cedar Shoals High School, 1300 Cedar Shoals Drive

C - Fire Station Number 7, 2350 Barnett Shoals Road.

SECTION 2. Unless prohibited by the federal Voting Rights Act of 1965, as amended, this ordinance shall become effective as provided for in the Athens-Clarke County Charter Section 2-204.

SECTION 3. All ordinances or parts of ordinances in conflict herewith are hereby repealed.
